# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.thewellpasadena.com, and Be Well Bodywork LLC and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, The Well Pasadena may collect personally identifiable information, such as your:

- First and Last Name
